Case Study - Rachel

This tool can acts as a reminder of immediate risk factors signalling very high risk other than the obvious physical violence/threats to kill.



How to help safely enable disclosures –What to ask

Ask (only if determined safe to do so)

- Are you having any problems with your husband/partner/anyone at home? Has someone hurt you?
- Are there things that happen at home that scare you? Are you afraid or anyone at home?
- Do you ever feel criticised and put down by those close to you?
- Does your partner/family member stop you from going out/contacting family & friends/ taking medication?
- Does anyone try to control you or what you do?
- Do you ever feel criticised and put down by those close to you?

Safety tip!: Don't ask the woman unless she is alone. If she has a child over 2 with her it is not safe to ask

Safety tip:: Check f interpreter is required (use independent one),. any disabilities or vulnerabilities that may hinder accessibility ADVANCE charity Safety y tip: Do not assume the gender of the partner when enquiring. This could alienate those in same sex relationships. Safety tip:: If English isn't her first language, ensure you use observe if anyone enters, an appropriate interpreter. Also, any disabilities. Safety tip:: Check who is at home, background noises and thereons tone of voice.

Unhelpful responses to DVA disclosures

Probing for further details Suggesting you can speak with the perpetrator.

Suggesting they consider leaving. Referring for couple's counselling.

Suggesting you can talk to the family and/or perpetrator

Questioning the disclosure

Suggesting anger management.

Acting as mediator.
